Sub: Allotment of S.K.O. for the Month of April & May'2010.

Department, Orissa, Bhubaneswar.

Government in F.S. & C.W. Department Orissa have communicated the allotment of SKO for each Month of April & May'2010. The allotment of 1296KL Kerosene for the each Month of April & May'2010. is distributed block wise and urban area wise as per the statement attached for issue @ 4 liters to approved BPL, APL & AAY card holders. The allotment may be changed on recommendation of concern authorities.

The Sub-Collector / Asst. Civil Supplies Officers / Block Development Officers / Executive Officers of Urban Areas / Marketing Inspectors / Inspector of Supplies are instructed to ensure full lifting of the allotted stock as per the norms prescribed by Government. The field executive staff should ensure timely lifting and arrival at the destination points / retail points and its proper distribution to the consumers at approved rate.

**The Sub-Collectors / B.D.Os are requested to distribute the stock through the retailers according to the ration cards immediately for BPL, APL and AAY card holders to avoid dislocation in PDS and the Block/ULB level S.K. Oil distribution plan should be prepared taking into consideration of the fake/bogus/ghost cards detected.** They will fix up G.P. wise entitlement as per the norms. The wholesalers are directed to lift the stock fully before 25<sup>th</sup> of each month and supply SKO to the Sub-Wholesalers as per the allotment indicated in the enclosed statement. Supply of SKO in excess of the said allotment to any Sub-Wholesalers will be viewed seriously.

The Sub-Collector, Jeypore will furnish monthly report after verification of the extra stock allotted to Jeypore Municipality M.F.P. Shop and Kotpad NAC.

The Block Development Officer, Koraput will furnish monthly report after verification of the extra stocks allotted to Upper Kolab cut-off area.
