

SCHEMES OF GOVT OF INDIA AND GOVT OF ORISSA IMPLIMENTED AND TO BE
IMPLIMENTED IN KORAPUT DISTRICT UNDER ASST DIRETOR OF TEXTILES,
KORAPUT ZONE.

A- DEVELOPMENTAL SCHEMES:-

- 1- R.L.T.A.P:- Funds under this scheme amounting Rs 75,000/- sanctioned under (State plan) District Window (2006-07) towards Aul Tree plantantation in Kotapad area, which will facilitate the weavers and dyers for natural Dying of yarn to give employment to more than 70 Families in the profession.
- 2- FIRE PROOF WORKSHED: - 5 Beneficiaries have been provided with (central plan) Rs 7000/- each for construction of fire proof work shed. Construction work has already been completed.
- 3- D.E.P.M:- Under this scheme 50 nos of weavers of Kotapad has been (C.S.P) given training on weaving in Broad Looms and on natural dying to enhance their skill in weaving & dying which will increase their earnings. The scheme has been implemented through Boyanika (Orissa State Handloom.WCS.Ltd Bhubaneswar).
- 4- PROMOTION OF HAND LOOM INDURSTRIES: - Under this scheme a proposal has (S.P) been submitted for Rs 4, 83,250/- to train 20 nos of weavers of Dangoriguda area on weaving.
- 5- INTEGRATE HANDLOOM DEVELOPMENT SCHEME: - (Groupaproch) Proposal (C.S.P) for sanction of founds under this scheme is being submitted to Directorate of Textiles. Orissa Bhubaneswar The survey work has already been completed.

B- WELFARE SCHEMES:-

- 1- MAHATMA GANDHI BUNAKAR BEEMA YOJANA: - In the above scheme the premium is Rs 330/- per weaver. Out of which the central Govt share is Rs 150/- and the L.I.C. share is Rs 100/-. The weaver has to share only Rs 80/- as premium to avail the benefits of Insurance as follows.
 - 1) Natural Death- Rs 60,000/-
 - 2) Accidental Death- Rs 150,000/-
 - 3) Total Disabled- Rs 150,000/-
 - 4) Partially Disabled- Rs 75,000/-

Till now 46 weavers have been enrolled under this scheme
by paying Rs 80/- as premium.

- 2- I.C.I.C.I LOMBARD HEALTH INSURANCE SCHEME: - (C.S.P) In this scheme the premium is Rs 781.60. The Central Govt share is Rs 642.47. For the rest Rs.139.13, the weaver has to pay only Rs 50/- and the other Rs 89.13 is born by State Govt. In this scheme wife husband and two dependant children of a family has to avail health services up to Rs 15,000/- in a year. The Weavers is issued with a Health Insurance Family Identity card to under go treatment in specific OPD'S.
But at present there is no OPD'S sponsored by the company in Koraput District. So the expenditure incurred by the weavers is reimbursable up to Rs 15,000/- steps are being taken to start O.P.D at Koraput by I.C.I.C.I Lombard.

Besides, the Hon' able Chief Minister of Orissa has declared a special package on Dt-29.08.2007 for Handloom weavers, for their over all development which is as follows.

- 1- Issue of photo Identity cards to Handloom weavers with in 2 years.
- 2- Creation of welfare fund.
- 3- Construction of 1000 work sheds under work shed- cum-Housing scheme.
- 4- 2000 weavers will be imparted training to develop their efficiency and skill up-gradation every year.
- 5- Establishment of raw-material bank in weaver concentrated villages /cluster.
- 6- Lunching of state owned integrated handloom cluster development programme at Nuapatna
- 7- Establishment of museum at Bhubaneswar for presentation and extension of heritage /tradition and culture of Orissa Handlooms.
- 8- Establishment of Apparel Training and design centre at Berhampur, Cuttack, Sambalpur, Rourkela and Baripada

Out of the above activities for Sl.no1 to 4 are taken up in 1st phase in this Handloom Zone.
